Your account information is kept completely confidential, it's always up to date, and, better still, Fidelity's Statement-*On-Demand* service is free!

The advantages of getting your statement on line include:

MORE CONTROL, IMMEDIATE ACCESS

You decide when you want to see your next account statement. You also decide what time period you want it to cover. Then, once you've previewed your account information on screen, you can easily print it out for your records.

PERSONAL RATE-OF-RETURN FOR THE SELECTED TIME PERIOD

No matter what time period you choose, your online statement will include a personal rate of return for that specific time frame.

QUARTERLY E-MAIL NOTIFICATION

Once you sign up for Statement-*On-Demand*, you'll automatically receive an e-mail notification each quarter that reminds you to review your statement, and links you directly to the online statement request screen.

LESS PAPERWORK

Viewing your quarterly statements on line means one less envelope to deal with. Instead, you receive your statements electronically—with the option to print them out if you wish. It's completely up to you.

CAN YOU EVER GO BACK TO PAPER?

Of course. Statement-*On-Demand* is an optional, free service; so, if you have limited access to the Internet, it might be better for you to stay with the paper statement format. (But we think that once you experience the convenience of Statement-*On-Demand*, you'll never go back!)

How to sign up for Statement-*On-Demand*:

1. Simply log on to www.fidelity.com/atwork and click "NetBenefits", then, select a Plan.
2. A consent screen will then appear that:
 - Offers you a choice of how to receive your online statements.
 - Explains the key features of Statement-*On-Demand*.
 - Asks you to indicate a statement delivery method. (If you request that your statements be delivered electronically, you'll be asked to provide an e-mail address.)
 - Explains how to change your statement delivery choice and update your e-mail address.
